OFFICE ORDER

Sub: Formation of Institute level Anti-Ragging Committee and Squads-Reg

Reference: AICTE Notification F.No.37-3/Legal/AICTE/2009 dated July 1, 2009.

The Hon'ble Supreme Court of India admitted and heard the above referred SLPs in relation to the menace of ragging in Technical Institutions / Universities/ Colleges in the Country. In this connection, a committee headed by Dr. R.K. Raghavan, former Director of CBI, for giving specific recommendations on effective prevention of ragging in educational institutions was constituted by the apex court. Accordingly, the Committee had carried out a very detailed study on the various factors contributing for ragging and collected the public opinion. Further, the Committee had submitted a detailed report with suitable recommendations and measures required to effectively curb the menace. The recommendations of the Committee were duly accepted. The following directives have been issued to all the educational institutes for necessary implementation by the Hon'ble Court and this institute proposes to follow them.

I. Factors enlisted by the committee:

1. Primary responsibility for curbing ragging rests with academic institutions themselves.
2. Ragging adversely impacts the standards of higher education.
3. Incentives should be available to institutions for curbing the menace and there should be disincentives for failure to do so.
4. Enrolment in academic pursuits or a campus life should not immunize any adult citizen from penal provisions of the laws of the land.
5. Ragging needs to be perceived as failure to inculcate human values from the schooling stage.
6. Behavioral patterns among students, particularly potential 'raggers', need to be identified.
7. Measures against ragging must deter its recurrence.
8. Concerted action is required at the level of the school, higher educational institution, district administration, university, State and Central Governments to make any curb effective.
9. Media and the Civil Society should be involved in this exercise.

Functions of Anti Ragging Committee:

It shall be the duty of the anti-ragging committee to ensure with the provisions of the regulations and any law for the time being in force concerning ragging and to deal and act promptly with the incidents of ragging brought to its notice.

The anti-ragging committee should keep tabs on the happenings/events related to ragging in campus or Off-campus within hostels and other designated places in the premises.

To ensure that the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and considering such other relevant information as may be required.

To monitor, direct and oversee the functions and performance of the anti-ragging squads in preventing and curbing of ragging in the institution.

Anti-Ragging Squads.

Functions and duties of Anti-Ragging Squads:

1. To be vigilant at all hours including at odd hours all round the campus and other places vulnerable to incidents of, and having the potential of, ragging and shall be empowered to inspect such places.
2. Conduct anonymous random surveys among fresher to check whether the campus is indeed free from ragging.
3. To conduct on-the-spot enquiry into any incident of ragging referred to it by the head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the anti-ragging committee for action under clause (a) of regulation 9.1 of U.G.C.
4. To ensure the display of posters/tabs on main and departmental notice boards and other places such as canteen, library, sports lounge, gymnasium, Bus stops and other prominent designated places.
5. To monitor the welfare of fresh students outside the campus.
6. Any other activity the anti-ragging committee might delegate to the squad.

Gender Sensitization Cell

Constitution

Introduction: The Director, Sir Madanlal Institute of Pharmacy, Etawah, Prof. (Dr.) U.S. Sharma, Constituted a Gender Sensitization Cell, Reference No. SMGI/SMIP/GSC/21 dated 25.08.2021.

Objectives : The Cell has been instructed to spread the message of Gender Equality in order to eliminate gender bias and gender insensitivity through Seminars, Poster Display, Organizing Exhibitions, Submitting Memorandums, Arranging Marches, Dharnas and if required take Additional Programmes.

The Cell has also been mainly entrusted with taking up cases of harassment and atrocities on female teachers, employees and girl students, enquire and take appropriate action against the culprits.

Action: The Cell will recommend action against the perpetrators of such offences to the Director/ Principal/ Head of the Departments/ Disciplinary Committee/ Officials of the University/ Vice Chancellor. The Cell may also approach directly to the local police and other relevant bodies. The action should be initiated within 24 Hours of the complaint.

Complaints: The victim of any incidence of atrocity or harassment can approach any of the members of the Cell, who will report the matter to the Secretary/ Chairperson, who will initiate enquiry and recommend action accordingly. If found necessary meeting of the General Body of the Cell be convened to discuss the complaint.

Members of the Cell: The Cell shall constitute 16 members including 8 student members. The teacher members will be drawn from different Departments of the institute keeping in view the convenience of operation. The Cell shall be headed by a Chairperson, Vice-Chairperson and a Secretary who will be executive authority.

In addition to the above said 16 members, the Chairperson can co-opt two members which will raise the strength of the Cell to 18 members. In case of any difference of opinion the decision of the Chairperson shall be final.

Selection/ dismissal of the Members of the Cell: The Director of the institute shall be the sole authority for selection/ dismissal of the members of the Cell.



Tenure: The tenure of the Cell shall normally be 1year.
